## Grant Review -

EMS County – Deadline for submitting receipts/invoices and cancelled checks is 3/31/2023. Dates for invoices are 9/1/22 – 3/31/23. Previous recommendation made by BCEMSPO that any funds that could not be distributed due to compliance issues would be pulled for Regional Projects has been implemented. These Regional Projects include but are not limited to continuation of the programs already in place for Fall Prevention and Injury Prevention and education for EMS outlined below.

**EMS RAC** – These funds are used for administrative purposes including ED hourly pay, office rent and expenses

**RAC Development** – As previously approved, purchases have been made to continue the Education and Injury Prevention programs as follows

- 80% split as follows
  - REMINDER OF Reimbursement of education and injury prevention expenses as submitted up to an amount equal to all submitting parties.
     Receipt and proof of payment due date is 3/31/2022.
  - Fall prevention items including but not limited to: night lights, non-skid socks, grabbers, toilet rails, bed rails, bath tub rails, socks assist
  - o Fire Extinguishers & CO2 monitors
  - Rescue Me Tags and all expenses associated with Project Rescue me including, postage & 1-800 #
  - o File of Life magnets
  - Child ID Safety tags
  - Vehicle Thermometers
  - STEMI/Stroke magnets
  - Tx Wristbands

Above will be available for all members

Senate Bill 8 (EMSE) – Presented an overview of the SB8 (EMSE) funds as follows: EMS Agencies will partner with current employees benefiting from sponsorship opportunities for EMT, AEMT and Paramedic training. Employees will obtain all necessary paperwork and return that paperwork to the RAC office. The student is responsible foe verifying the paperwork was received within the office and after enrolling in an accredited program verifying payment has been made to that program. If a student approaches the RAC for

sponsorship, the RAC will help facilitate the relationship between the student and EMS Agency in order for a sponsorship to occur. If the student fails to complete the program, the Sponsoring Agency will attempt to collect the scholarship from the student and reimburse the RAC the amount paid. If the EMS Agency is unable to collect the funds, the RAC office will attempt to collect the funds. The student will also commit to work 96 hours a month for one year if EMT and 2 years if AEMT or Paramedic with the sponsoring agency. Failure to complete this commitment will also result in the student repaying the scholarship to the RAC.

A secondary application has been approved by DSHS (Dir Joe Schmider) intended for students that are unable to secure a sponsoring EMS agency. Those students can be a recipient of the funding but pledge to first attempt employment within the 16 counties representing BCRAC and if that is not available should secure employment within a rural area of Texas at which time, the oversight of the SB8 funding will be transferred to the corresponding RAC of the county of employment.


