Tobacco/LPG — Injury Prevention and Education Committees have recommended FY19 funds be used to reimburse compliant members for education and injury prevention expenditures. Compliant members should submit invoices and proof of payment to the RAC office before 3/31/2019 for reimbursement. The amount to be reimbursed is undetermined until after 3/31/2019 at which time the amount available will be divided equally by the compliant members having submitted all required documents. (It is recommended that invoices and proof of payment should be at least equal to \$2500 but not guaranteed this total amount will be reimbursed.) In addition, it is recommended to use \$15,000 for education benefitting the RAC membership and \$2400 for the purchase of additional fire extinguishers and CO2 detectors.
